REGISTRATION CERTIFICATE OF PROJECT

This registration is granted under section 5 of the Real Estate (Regulation and Development) Act, 2016 [hereinafter referred as RE(RD) Act, 2016] to the following project under project registration number DLRERA2026P0002 -

Project: ELDECO CAMELOT

Location: Plot ID 3753, Pocket A-2, Sector-17, Dwarka, New Delhi-110075.

(hereinafter referred as 'Project: ELDECO CAMELOT')

1. **The project will be implemented by M/s Eldeco Green Park Infrastructure Limited**, having its registered office at **201-212, Splendor Forum, 2nd Floor, Jasola District Centre, New Delhi-110025**. (hereinafter called as "Promoter").
2. This registration is granted subject to the following conditions:
 - (i) The Promoter shall not deviate from the approved layout and sanctioned building plans without the prior approval of the Competent Authority and this Authority;
 - (ii) The Promoter shall execute and register a conveyance deed conforming to provisions of the RE (RD) Act, 2016, in favour of the Allottee or the Association of the Allottees, as the case may be, of the apartment, plot or building, as the case may be, or the common areas as per section 17 of RE(RD) Act, 2016;
 - (iii) The Promoter shall mention all details regarding acquisition of land for the project by way of lease or purchase or any other means in the "Agreement for Sale" and enter into an 'Agreement for Sale' with each allottee strictly as per the model 'Agreement for Sale' given in Annexure of the National Capital Territory of Delhi Real Estate (Regulation and Development) (Agreement for Sale) Rules, 2016;

(iv) The Promoter shall disclose all liabilities and encumbrances on the land for the project or projects in the 'Agreement for Sale';



- (v) The Promoter shall not create any new liability or encumbrance on the land for the project or the project without prior approval of this Authority;
- (vi) The Promoter shall deposit seventy percent of the amounts realized by the promoter in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost to be used only for that purpose as per sub-clause (D) of clause (i) of sub-section (2) of section 4 of the RE (RD) Act, 2016;
- (vii) The Promoter shall neither seek nor accept more than 10 percent of the cost of unit/apartment without entering into and registering written 'Agreement for Sale' as per section 13 of the RE (RD) Act, 2016;
- (viii) The Promoter shall mention details of parking slot(s) attached to each unit/apartment in the 'Agreement for Sale';
- (ix) The Promoter shall mention the number of entrances, lifts and materials to be used in the 'Agreement for Sale';
- (x) The Promoter shall mention details of all common facilities proposed to be developed as part of this project in the 'Agreement for Sale';
- (xi) The basement of the project shall be used only for the purposes indicated in the sanctioned building plan;
- (xii) The Promoter shall advertise, market or sale the project only on carpet area basis and not on the basis of super area or super buildup area basis;
- (xiii) The Promoter shall sell CSP units only as CSP units and strictly in accordance with the provisions of Master Plan of Delhi-2021;
- (xiv) The Promoter shall not give any assured return or commitment charges or assured rentals or any other rebate by any other name, except the rebate for early payment as envisaged under 'The National Capital Territory of Delhi Real Estate (R & D) (Agreement for Sale) Rules, 2016";
- (xv) The Promoter shall withdraw money from the seventy percent Project RERA Escrow Account only in proportion to the percentage of work completed on ground at any point of time, and not more than that under any circumstances;
- (xvi) The Promoters shall seek applications for allotment of units in the subject project and issue allotment letters only in the formats enclosed with this Registration Certificate.
- (xvii) The Promoter shall ensure that no clause in 'Allotment Letter' or 'Agreement for Sale' is included in contravention of the provisions of RE (RD) Act, 2016;
- (xviii) The registration of this project shall be valid up to 23.11.2030 unless extended by this Authority in accordance with RE (RD) Act, 2016 and the rules made thereunder;



- (xix) The Promoter shall submit Quarterly Progress Reports as per Section 11 of RE (RD) Act, 2016 detailing the physical and financial progress made on the project till such date the Authority declares the project closed.
- (xx) The Promoter shall not contravene the provisions of any other law for the time being in force as applicable to the project.

3. If the above-mentioned conditions are not fulfilled by the Promoter, the Authority may take necessary action against the Promoter including revoking the registration granted herein, as per the RE (RD) Act, 2016 and the rules and regulations made thereunder.
